## Clearwater Fast Pitch Softball Group, Inc. Player Financial Responsibilities

As you may or may not know, it is quite expensive to participate in a traveling club. The following include some expenses that are covered by your player participation fee: uniform (**two shirts, two shorts, compression shorts, socks, sliders, hat, and bat bag**), tournament entry fees, team insurance, and team equipment. You will be expected to pay for your hotel, meals, and travel expenses.

To help cover some of the costs, we plan on conducting several fund-raisers during the months ahead. Details will be provided at a later date.

**REGISTRATION FEE** – \$\_\_\_\_\_ if you played in the Clearwater Bullets organization last season, and \$\_\_\_\_\_ if you are a new player. This fee is due by the fifth practice after being accepted on the team. Payment can be a personal or business check, personal sponsorship, or team fund-raising.

**PLAYER PARTICIPATION FEE** – \$\_\_\_\_\_ for the year. This fee is due in the following stages:

Payment can be made either by business sponsorship, personal payment, or by team fund-raising.

**BUDGET** – Any additional money needed to reach our budget goal of \$ \_\_\_\_\_ will come from organizational and team activities.

**FINANCIAL RECORDS** – Financial records are kept by the Manager. A financial statement is available by request for your daughter only. Team expense statement is also available upon request.

**FUND-RAISERS** – There will be several team and organization fund-raisers in which parents and players are required to participate. Money raised from optional participation team fund-raisers will be divided amongst the players who participate in the fund-raiser. The method of distribution of money raised from organizational fund-raisers will be disclosed at the time the event is announced to the team.

**PLAYER TERMINATION** – Any player that resigns or is terminated from this team will forfeit her registration and fund-raising money. Disputes should be brought to the attention of the Bullets' President, and will be resolved in accordance to the Bylaws of the Bullets' organization.

Players who quit or are terminated from the team must pay their expenses incurred. It is your responsibility to settle your account with the team manager. No player will be permitted to play for a Bullets' team until the debt incurred is satisfied. The Bullets' Treasurer will retain a copy of the player's detailed account for future reference. Disputes should be brought to the attention of the Bullets' President, and will be resolved in accordance to the Bylaws of the Bullets' organization.

**FINANCIAL AID** – All players selected by the coaching staff can play. Financial help will be arranged for those who truly need it.
